

Dear Parents/Carers,

Owing to recent changes in Government legislation, we wanted to clarify for parents the funding arrangements around "free school meals".

### **1) UNIVERSAL INFANT FREE SCHOOL MEALS (UIFSM)**

From September 2014 all children who are in Reception, Year 1 or Year 2 in a state-funded school will be offered a free school meal.

### **2) PUPIL PREMIUM FREE SCHOOL MEALS (FSM)**

This is additional funding available (£1,385 per child) from central government for every child whose parent is receiving one of the welfare benefits listed below.

It is therefore important to sign up for free school meals (Pupil Premium), even if your child is in Reception, Year 1 or Year 2 so that your child's school receives as much funding as possible.

The more parents that take up their entitlement to free school meals (Pupil Premium) for their children, the more funds Caversham Primary will receive to invest in your child's education.

This extra money, currently totalling £35k, is used to fund a range of educational opportunities for pupils, clubs, visits, support staff, play therapy, reading support to name a few.

### **WELFARE BENEFITS CREATING PUPIL PREMIUM ELIGIBILITY:**

1. Income Support
2. Income based Jobseekers Allowance
3. Income related Employment and Support Allowance
4. Support from NASS (National Asylum Support Service) under part 6 of the Immigration and Asylum Act 1999
5. The guarantee element of State Pension Credit
6. Child Tax Credit provided they are not entitled to Working Tax Credit and have an annual income that does not exceed £16,190
7. Working Tax Credit run on - paid for 4 weeks after you stop qualifying for Working Tax Credit
8. Universal Credit - if you apply on or after 1 April 2018 your household income must be less than £7,400 a year (after tax and not including any benefits you get)

In order to qualify for Pupil Premium (FSM) you need to complete an application form termly which is available from the school office.

**PUPIL PREMIUM FREE SCHOOL MEALS PUPILS ARE ALSO ELIGIBLE FOR A SET OF SCHOOL LOGO SCHOOL UNIFORM AT THE START OF EACH ACADEMIC YEAR.**

**GUIDANCE NOTES FOR PARENTS AND GUARDIANS**

**ELIGIBILITY FOR ENTITLEMENT**

If you are in receipt of any of the following you will be entitled to Free School Meals for you child:

- Income Support
- Income-based Jobseekers Allowance
- An income-related Employment and Support Allowance
- Support under part VI of the Immigration and Asylum Act 1999
- Child Tax Credit (provided they are not entitled to Working Tax Credit) and have an annual income (as assessed by Her Majesty's Revenue and Customs) that does not exceed £16,190
- The Guarantee element of State Pension Credit
- Note: *If you are in receipt of Working Tax Credit during the four-week period immediately after your employment ceases, or after you start to work less than 16 hours per week, your child/children are entitled to free school meals.*

**CONFIRMATION OF ELIGIBILITY**

Your application may be checked using The Department for Education Free School Meals Eligibility Checking Service using the information you have provided in Part A of this form. The results will be a yes/no confirmation and your child's school will be informed of this.

**DOCUMENTARY EVIDENCE**

You may be requested by the school to provide documentary proof of entitlement.

**CHANGE OF CIRCUMSTANCE**

You must inform the school immediately of any change in your benefit entitlement.
